Strengthening the Humanitarian-Development Nexus for Nutrition in Yemen

Introduction:

"Nutrition can't wait" Nutrition remains a priority despite the competing urgent humanitarian issues. However, 2020 saw developments in global health, with the Covid-19 pandemic representing a global health crisis that threatened the entire humanitarian presence. The Covid-19 pandemic has revealed a clear imbalance in health and economic systems, both at the international and country levels.

During the response to the Covid-19 pandemic, preventive safety procedures were identified to reduce its spread among communities, and procedures were taken to protect and promote good nutrition. This is through the integration of nutrition procedures into Covid-19 response plans and the protecting existing nutrition programs, particularly for the most vulnerable. The role of government coordination bodies of the Nutrition Upgrading Movement and multi-stakeholder platforms in the Member States is to introduce these procedures to reduce the direct and indirect effects of the Covid-19 pandemic on malnutrition.

Precautionary procedures in 2020 suspended most of the planned activities, and the health crisis caused a low level of financial allocations from donor countries to countries receiving both humanitarian and development assistance. In view of this, all have affected the Scaling Up Nutrition Secretariat (SUN Yemen) these procedures and difficulties. Most annual activities were carried out via e-mail and meetings on electronic applications or individual meetings. The Secretariat postponed the implementation of many activities that needed greater financial allocations.

Nutrition Budget Analysis of Yemen's in 2020

The Coordinating Secretariat for SUN Yemen carried out the nutrition budget analysis activity during the period (April-July 2020), which represents an annual activity carried out by the Secretariat as a tool for measuring the funds allocated for investment in nutrition, especially those aimed at measuring resources allocated to reach the most vulnerable populations.

The technical team on raising the level of nutrition from stakeholders (health, agriculture, water and sanitation, fish and education), in addition to the participation of the private sector represented by the General Federation of Chambers of Commerce, Yemeni Food Bank, the Red Crescent, the Social Fund for Development, the Social Welfare Fund as well as Hayel Saeed Anam Charity Foundation, participated in the meeting held in the first week of May 2020. The purpose of the meeting was to:

• Clarify the importance of the nutrition budget analysis activity and the importance of collecting and providing nutrition tracking data for the year 2019.

Results of the meeting:

- Collecting new data for (14) projects from different sectors (health, agriculture, water and sanitation) during the period 2019.
- Adding other sectors to tracking nutrition spending in Yemen (the Yemen Red Crescent Society, Ministry of Social Affairs / Social Welfare Fund, Yemeni Food Bank Foundation and the Coordinating Secretariat to SUN Yemen.

At the meeting, many participants discussed part of their projects and the way to intervene, and the importance of sectoral efforts and coordination to ensure greater population effectiveness.

At the end of the meeting, Mr. Abdulkarim Nasser, Head of the Secretariat, stressed the importance of the Secretary-General providing data to the nutrition project Secretariat to enhance intervention and help decision-makers as an important part Formulate policies to improve the quality of enterprises.


Inception Phase of Multi-Sector Nutrition Action Plan

Introduction

Implementation of the MSNAP aims for a three-year implementation phase. Following the endorsement, a six-month inception phase will allow preparing remaining details, operationalizing and clarifying responsibilities, initiate the implementation, establish the M&E systems and Inception commence the accelerated actions.

Objective of the inception phase:

- Gaining stakeholders concurrence and establish the joint coordination and implementation structure
- Clarifying and prioritizing the needs to be solved;
- Operationalize and prepare a road map agreeing on responsibilities and Inception tangible actions. Agree on viable solutions to provide services and protect the most vulnerable populations;
- Setting up the work environment and team, and the reporting and monitoring system; and
- Identify financial gaps and mobilize additional resources



Key steps to achieve Objectives of the inception phase :

- I. Working with governmental as well as non-governmental partners to implement all aspects of the MSNAP and CRF
- II. launching and Roll out of the MSNAP and CRF and its advocacy strategy.
- III. Developing a financing plan: Information of the actual funding status and the remaining funding gaps and priorities will be assessed. The inception phase will be used to further assess the actual funding status and pipelines as well as opportunities to leverage existing funding sources, to specify and prioritise the additional needs and present the funding gap.
- IV. Elaboration of a nutrition budget advocacy plan
- V. Establishing the M&E System

Roadmap for the Inception phase:

- Expand SUN Steering Committee to include all stakeholders in Yemen (Reaching consensus);
- Operational details to provide services to the most vulnerable populations, responsibilities;
- A nutrition budget advocacy plan;
- Establishing the M&E System;

 - \Rightarrow Procedures for conflict of interest management
 - \Rightarrow Monitoring and evaluation procedures

of SUN 2020	 The consolidated reporting form (CRF) was completed and reviewed in the first quarter of 2020. Discussing the CRF with relevant actors and align it with national and sectoral plans. The humanitarian and development link is strengthened through the coordination of the humanitarian response plan, group activities, the CRF and sectoral plans in executive ministries. The contributions of the business and civil society organizations are being discussed. Coordination is being conducted with the private sector to support the implementation of the SBN plan. 4. 
Strengthening the Humanitarian-Development Nexus for Nutrition in Yemen

It showed an overview of the nutrition situation in Yemen and reviewed figures and ratios that show the situation for many diseases related to malnutrition, including:




